

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding ("MOU") is made on 1st day of July, 2022 ("Execution Date"), by and between:

Seekify Technologies Private Limited, doing its business in the name of Seekho is a private limited company incorporated under the Companies Act, 2013, holding corporate identification number U74999DL2019PTC351181 and having its registered office at 2nd Floor, C-46, Neeti Bagh, Delhi-110049, India (hereinafter referred to as "Seekho" or "Service Provider" which expression shall unless repugnant to the context include its successors, affiliates and its permitted assignees) of the FIRST PART;

AND

Institute of Business Management, GLA University having its registered office at 17km Stone, NH-19, Mathura-Delhi Road P.O. Chaumuhan, Mathura-281406 (hereinafter referred to as "Institute" or which expression shall unless repugnant to the context include its successors, affiliates and its permitted assignees) of the SECOND PART.

(Seekho and GLA University hereinafter collectively referred as "Parties" and individually as "Party".)

WHEREAS:

- A. Seekho represents that it is *inter alia* engaged in the business of **Upskilling Students with Industry relevant knowledge**.
- **B.** The Parties are desirous of entering into an arrangement whereby the importance of industry-based knowledge and practical knowledge in promoting industry collaboration and increase contribution to economic development;
- C. Parties have agreed that the terms and conditions as set out in this MOU shall form the basis of such engagement.

NOW THEREFORE IT IS AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

- 1. SCOPE
- 1. **Institute** hereby appoints and engages Seekho, and Seekho hereby accepts this appointment and shall execute a Industry relevant Training program to the students as per Annexure 1.

2. DUTIES AND RESPONSIBILITIES

- Seekho shall develop and design the course curriculum, and delivery plan for lectures ("Deliverables") and further
 engage such faculty or experts to train and impart knowledge to the candidates enrolled to receive such Services
 through the utilisation of the Deliverables.
- Seekho shall ensure that the candidates enrolled to receive such Services through the medium of Deliverables are equipped with practical training and skills in such manner as may be mutually decided between the Parties.
- Institute shall establish an eligibility criterion including but not limited to the assessment of the pre-requisite skills
 of the candidates enrolled to receive such Services.

 Institute shall oversee and monitor the candidates enrolled to receive the Services which shall include but is not limited to compiling and collating the attendance registers, timely submission of assignments and any other such requisites.

3. SERVICE FEES AND PAYMENT TERMS

 Institute shall pay to Seekho and Seekho agrees to accept from the Institute as full compensation for the Services provided hereunder at the rates, and according to the terms and conditions set forth in Annexure 2 of this MOU.

4. TERM AND TERMINATION

- This MOU shall come into effect as of the Execution Date and shall continue to be in full force and effect, unless terminated as per the terms of this Clause 4.
- Either Party may terminate this MOU at any time by giving not less than 60 days prior written notice to the other Party to this effect.
- In the event of termination of this MOU by either party for any reason, both the parties under this MOU shall fulfil their duties and responsibilities in relation to previous batches onboarded and discharge payment obligation as the case may be.

5. CONFIDENTIALITY

1. Each Party shall keep all information and other materials passing between it and the other Parties in relation to the transaction contemplated by this MOU as well as the existence and the terms and conditions of this MOU ("Information") confidential and shall not, without the prior written consent of the other Party, divulge the Information to any other Person or use the Information other than for carrying out the purposes of this MOU.

6. INDEMNIFICATION

Each Party shall, at its own cost and expense, indemnify, defend or at its option settle, and hold the other Party
and its employees harmless from and against any and all losses, liabilities, claims, actions, costs and expenses,
including reasonable attorneys' fees and court costs, relating to, resulting from or in any way arising out of breach
of any provisions of this MOU and/ or its representations, warranties and/or undertakings by such Party.




- Notices: Unless otherwise stated, all notices, approvals, instructions and other communications for the purposes
 of this MOU shall be in writing and may be given by facsimile, by personal delivery or by sending the same by
 courier or registered post at the address or e-mail address provided in this MOU.
- Governing Law and Jurisdiction: This MOU shall be interpreted and governed in all respects by the laws of India.
 The Parties agree that the courts of New Delhi, India alone and no other courts shall have the jurisdiction to entertain and try any disputes arising from and out of the provisions of this MOU or any other agreement related hereto.
- Assignment: Neither Party shall be entitled to assign, sub-contract, transfer, or pledge to a third party, or create
 any encumbrance whatsoever, over any of its rights and obligations under this MOU without the written consent
 of the other Party.
- Amendment: Any amendment or variation of the terms of this MOU shall be valid only if mutually agreed and executed in writing by or on behalf of both the Parties.
- 5. Relationship of the Parties: Seekho and Institute are independent contractors for the purpose of this MOU. Neither the execution, delivery nor performance of this MOU will be construed to constitute either party as an agent or representative of the other for any purpose. Neither the execution, delivery nor performance of this MOU will be deemed to establish a joint venture or partnership between the Parties. Except as otherwise provided herein, neither Party has the authority to (i) bind the other Party by or to any contract, representation, understanding, act or deed, (ii) represent that either Party is an agent of the other Party, or (iii) represent that either Party is responsible for the acts or omissions of the other Party.
- 6. <u>Severability:</u> If any term, provision, covenant, or condition of this MOU is held by a court or regulatory body of competent jurisdiction to be invalid, void, or unenforceable, the rest of the MOU shall remain in full force and effect and shall in no way be affected, impaired, or invalidated unless removal of that provision results in a material change.
- 7. Entire Agreement: This MOU along with the Recitals constitute the entire agreement between the Parties with respect to its subject matter and supersedes all prior written or oral negotiations and/or agreements between the Parties with respect thereto and there are no other representations, understandings or agreements between the Parties relative to such subject matter.





- 2.
